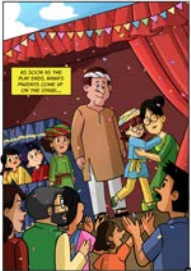

WHAT IS A CASE MARGINAL?

Each member of a committee or a panel will have their own list of cases on which they will vote. The list of cases will be made up of individual cases that have been referred to them and referred to in a recent volume of the Journal of Evidence, Evidence Review and Proceedings.

- The jury is a group of people who are chosen to hear the evidence and to decide the facts of the case. They are usually chosen from a list of names that is compiled by the court. The jury is usually made up of 12 people, but it can be as few as 6 or as many as 24.
- The jury is responsible for determining the facts of the case and for applying the law to those facts. They are not responsible for determining the law itself.
- The jury is usually sworn in before they begin their duties. They are also usually given instructions by the judge on how to conduct their duties.
- The jury is usually sequestered from the public and from the media during the trial. This is to ensure that they are not influenced by outside information.
- The jury is usually given a verdict at the end of the trial. This verdict is then used by the judge to determine the sentence for the defendant.
