Disclosure of Significant Accounting Polices and Note to Accounts attached to & forming part of the Balance Sheet of Kailash Satyarthi Children's Foundation, New Delhi as at 31st March 2024.

1. Basis of preparation of Financial Statements

The Trust has followed cash system of accounting during the year 2023-24 and recognizes significant items of Income & Expenditure on cash basis.

2. Depreciation

The Trust has provided depreciation on Fixed Assets at the rates prescribed under the Income Tax Act, 1961.

- 3. The Balance in Capital Fund, represent the money utilized for acquiring Fixed Assets and interest earned on deposits. Whereas the Programme Balance represent the unutilized balance lying with the Trust against various projects at the end of the year.
- 4. The expenses are incurred under various heads for different programmes undertaken by the Trust from time to time & are clubbed under those programmes only.
- 5. The registered office of the trust is located at L-6, IIIrd Floor, Kalkaji, New Delhi -110019, which is owned by another Society named as Association for Voluntary Association (AVA). A no objection certificate has been obtained by the Trust from AVA to run its office from that premises.
- 6. The head office of the trust is located at L-64, Kalkaji, New Delhi-110019 which has been taken on rent.
